June 27th is Helen Keller Day, celebrating this American author, political activist, and first deaf, blind person to earn a bachelor of arts degree. Her teacher and lifelong friend. Anne Sullivan, developed a personalized method to teach Helen words, multiplication tables, and the Braille system. The latter soon became famous for her incredible progress, helping increase awareness and funding for The Perkins school for the blind. Helen was rewarded honorary degrees from both Temple University and Harvard University. The observance was proclaimed in 1960 by the mayor of Newark, Leo P. Carlin, followed by US president Jimmy Carter and many organizations, particularly those helping the blind and deaf.

Medicare & Coronavirus

The Public Health Emergency for COVID-19 ended on May 11, 2023.

- Medicare continues to cover vaccines without cost sharing.
- You might have cost sharing for COVID-19 diagnostic tests.
- Telehealth services continue through December 31, 2024. Get a COVID-19 vaccine as soon as you can.
- Medicare covers the updated COVID-19 vaccine at no cost to you. Medicare covers the vaccine for anyone who has Medicare.
 - The updated 2023-2024 Pfizer-BioNTech or Moderna vaccine is available for people 5 and older.
 - Note: Some adults 18 years and older who have completed their primary vaccine series have the option to get a Novavax vaccine instead of the updated Pfizer-BioNTech or Moderna COVID-19 vaccine. Stay up to date with COVID-19 vaccines at CDC.gov.
- If you:
 - Recently had COVID-19: The CDC recommends you wait at least 3 months before you get the updated COVID-19 vaccine.
 - Are moderately to severely immunocompromised (like people who have had an organ transplant and are at risk for infections and other diseases) and got 1 shot of the updated vaccine at least 2 months ago: Check <u>CDC.gov</u> to find your vaccination schedule.

If you have Medicare and have a disability or face other challenges in getting to a location away from home for a vaccination. Medicare will pay a doctor or other care provider to give you the COVID-19 vaccine in your home. You might need to give them your Medicare number for billing, but there's still no cost to you for the vaccine and its administration.
